With support of BELDS (2019-2020)



- A situational analysis of preschool education in Kyrgyzstan was conducted using the BELDS tool;
- a Coordinating Committee (BELDS) was created under the Ministry of Education and Science of the Kyrgyz Republic to develop a Strategy for the Development of Education 2040, an Action Plan for 2021-2023 using the BELDS tool;
- analysis of financing of preschool education with the support of BELDS.
- With the financial support of BELDS, Advocacy Paper on effective financing of preschool education in Kyrgyzstan were developed

Within KIX

The Strategy for the Development of Education 2040 (SDE 2040), the Action Plan for 2021-2023 (**toolkit 1.2. Conceptual framework: Build to Last: A framework in support of universal quality pre-primary education**)

The national coordinator of KIX, based at the Ministry of Education and Science of the Kyrgyz Republic, has been hired, assists the Department of Preschool Education of the Ministry of Education and Science of the Kyrgyz Republic in implementation AP 2021-2023.

The KIX work plan was developed in accordance with the Action Plan (AP) for 2021-2023 and agreed with the Ministry of Education and Science of the Kyrgyz Republic (**toolkit 3.2. Criteria, Recommendations and Checklists: Defining ECE Indicators and Target Setting**);

The Coordination Committee under the Ministry of Education and Science of the Kyrgyz Republic continues its work (the regulations have been updated, the composition using the KIX tool (**toolkit 1.4 Tip Sheet: Strategic Ideas for Establishing the ECE Technical Working Group**), approved by the order of the Ministry of Education and Science of the Kyrgyz Republic);

Within KIX

Assistance is provided to the Ministry of Education in the development of per capita financing in order to create a system of inclusive and high-quality preschool education based on the results of the analysis of financing of preschool education (**toolkit 3.3. Tips, Checklist, and Examples: ECE Simulation Models**);

PPP mechanisms in preschool education are being finalized (Development of a regulatory framework and a PPP mechanism in the preschool sector and approval by the Government of the Kyrgyz Republic);
